Regular Board of Education Meeting, February 25, 2009

Vice-President, Mr. Everett Vail, opened the regular meeting at 7:05 p.m. with Mrs. Mary Beth Hammond, Director of Early Childhood Education & Literacy Programs, leading the Pledge of Allegiance.

Discussion Item #1, Mrs. Lisa Hoag, Bus Route Coordinator, shared the goals and initiatives for the 2008-2009 school year in the Transportation Department. Mrs. Hoag included information regarding number of employees, bus routes, and reviewed the Bus Replacement Plan in preparation for a school bus proposition in May. Mrs. Hoag stressed the need for diagnostic software that would assist the mechanics with a bus's mechanical problem. Currently the mechanics have to go off site to have this function done at a cost each visit. The bus lift at the garage is not working properly and the need to replace it was addressed. The district will look into buying a Transfer Transportation software system as a way of minimizing routing and cost saving measures.

Discussion Item #2, Mrs. Nancy Galusha, Food Service Director, presented the goals and initiatives for the 2008-2009 school year in the Food Service Department. Mrs. Galusha also provided the Board with budget recommendations for the 2009-2010 school year and showed eligibility comparison charts along with participation percentages.

Discussion Item #3, President, Superintendent and Committee Reports: Mr. Carmen Ciullo thanked the administration and the budget committee for the efforts made preparing the budget draft. A public meeting was suggested for March 9, 2009 at 7 p.m. as an open forum to present the budget draft to the community. It was decided to contact residents who have shown interest to open up the floor to their suggestions and concerns.

Mr. Vail thanked Mr. Ciullo, Mrs. Elizabeth Donahue and all the staff for a promising budget. Mr. Vail appreciated the effort made to keep costs down.
