• Dr. Thomas J. Douglas reported that Governor Paterson has announced a delay in state aid. Hopefully the release of funds will be soon. Based on the budget numbers, Chenango Valley will receive approximately \$530,000 less but this is not as severe as other Districts based on wealth and population.

- A thank you goes out to High School teacher, Garry Scutt, who has created along with his classes and mass produced "Chenango Valley Admirable Qualities" poster that states ten qualities in hopes that students will support and strive to live by. - Mr. James Penwell reminded Board members who will be attending the Joint Dinner meeting at the Terra Cotta Room in downtown Binghamton on Thursday, January 21, 2010.
