Mr. James Penwell attended the opening day of school presentation. Mr. Penwell provided the Board with Dr. Douglas' four key beliefs and the CV Way! Mr. Penwell asked if anyone was interested in attending the New York State School Boards Association convention in New York City. Mrs. Roberts had attended the new Board members training and commented on the fiscal oversight workshop.

Dr. Thomas J. Douglas rode one of the buses on the first day of school for students. He noted only a few hiccups but overall the transportation department had few issues. Reports of opening at all buildings and departments were sent to Board members by email. The major concern was the size of classrooms.

Discussion Item #1, Transportation Department Supervisor, Mr. Chris Fairbairn shared with the Board of Education his NYS Department of Motor compliance plan for the 2009-10 school year. Mr. Fairbairn is a School Bus Driver Instructor (SBDI) and his first concern is keeping our children safe. His presentation referred to qualifications needed both annually and biannually along with his vision for the future of the transportation department. The department has purchased a Transfinder software program which should be fully in place by the 2010-11 school year. This software program is designed to assist in bus routing issues.
